<p>UNIFORM AND PERSONAL APPEARANCE REGULATIONS AGREEMENT</p> <p>IN ACCORDANCE WITH PUBLISHED USNCC REGULATIONS, THE UNSCC UNIFORM MANUAL AND US NAVY OPNAV INSTRUCTION 5760.5E, BY MY SIGNATURE I HEREBY ACKNOWLEDGE AND AGREE TO COMPLY WITH THE TERMS AND CONDITIONS SET FORTH HERIN REGARDING THE WEAR, UPKEEP AND CARE OF ISSUED UNIFORMS AND COMPLY WITH STANDARDS REGARDING APPEARANCE, GROOMING AND CONDUCT IN UNIFORM.</p> <ol style="list-style-type: none"> 1. I ACKNOWLEDGE THAT IT IS A PRIVILEGE TO WEAR THE UNIFORM OF THE UNITED STATES NAVY AND AGREE TO UPHOLD A PROFESSIONAL APPEARANCE THAT WILL REFLECT POSITIVELY ON THAT HONOR. 2. AS PER USNSCC REGULATIONS, CH3, SEC 3.08 UNIFORMS AND INSIGNIA REMAIN PROPERTY OF THE UNIT AND MUST BE RETURNED UPON DISCHARGE FROM THE CORPS. 3. UPON REQUEST, THE UNIT SHALL BE REFUND THE UNIFORM DEPOSIT PROVIDED ALL UNIFORM COMPONENTS ARE RETURNED IN SERVICABLE CONDITION. 4. I ACKNOWLEDGE THAT MY CADET HAS BEEN ISSUED THE PRESCRIBED UNIFORMS IN ACCORDANCE WITH THE UNIT SEA BAG LIST UNDER DIRECTION OF THE UNIT SUPPLY OFFICER. 5. UNIFORMS MAY BE ALTERED TO IMPROVE FIT AND APPEARANCE PROVIDED ALTERATIONS DO NOT CUT, TRIM OR GLUE MATERIAL OR INSIGNIA IN MANNER THAT RENDERS THEM UNSERVICEABLE. 6. I AGREE TO REPLACE AT MY OWN EXPENSE OR REIMBURSE THE UNIT FOR THE REPLACEMENT COST OF MISSING/LOST UNIFORM ARTICLES PER THE PUBLISHED GENERAL PRICE LIST (ANNEX A). 7. I AGREE TO REPORT ANY LOST OR DAMAGAED UNIFORM COMPONENTS AND SEEK TO REMEDY UNIFORM DISCPREANCIES THOUGH THE UNIT SUPPLY OFFICER IN A TIMELY MANNER. 8. I AGREE TO COMPLY WITH ALL REGULATONS CONTAINED IN THE USNSCC UNIFORM MANUAL REGARDING GROOMING STANDARDS AND PERSONAL APPEARANCE. 9. I UNDERSTAND THAT FAILURE TO COMPLY WITH ONE OR MORE OF THESE CONDITIONS WILL RESULT IN MY CADET BEING SENT HOME FROM DRILL, AND/OR RESTRICTED FROM FUTURE USNSCC ACTIVITIES UNTIL SUCH TIME THE INFRACTION IS REMEDIED.
